

## Link Housing Survey Daily Draw – Terms and Conditions

Details of Prizes and Values: Link Housing will be giving away a \$50 EFTPOS gift card voucher each weekday from Thursday 07 March 2019 to Thursday 18 April 2019, to anyone who completes the Health, Well-being and Community Engagement survey including their contact details. Each prize is valued at \$50. Total maximum prize pool valued at up to \$1550. The prize is not transferable and is not redeemable for cash. Each winner will be selected at random by a Link Housing Staff member.

Methods of Entry: Entry into Link Housing Survey Daily Draw is free of charge. Tenants that complete the above survey including their contact details and return their forms to Link Housing will be automatically entered into the draw. Tenants can opt not to be entered into the draw by emailing [enquiries@linkhousing.org.au](mailto:enquiries@linkhousing.org.au).

Entry Restrictions: Entry is open to Link Housing tenants who comply with the terms and conditions and not employees of Link Housing and their families.

Date, Time, Place of Draw: Draws will be conducted at the Link Housing office in Chatswood at 5pm each weekday until the expiry date. Winners will be notified in writing and/or by telephone by Link Housing's Client Services team.

Winner Announcement: Winners have one week to claim the prize. Names of the winners will not be published but a record kept for access in the event that the winners names are required for compliance or legal reasons.

Redraw for Unclaimed Prizes: Winners have one week to claim the prize. All unclaimed prizes will be entered into the unclaimed prize redraw. Unclaimed prizes will be drawn from all entries received across the Prize Draw. Prizes that are unclaimed will be redrawn at the Link Housing office, Chatswood. Winners will then be contacted in writing and by telephone. Winners from the unclaimed prize redraw will have one week to claim their prize. Names of redraw winners will not be published but a record kept for access in the event that the winners names are required for compliance or legal reasons.
